

UNITED BUSINESS MEDIA TO BE REMOVED FROM S&P EUROPE 350

LONDON, JUNE 6, 2018: S&P Dow Jones Indices will make the following changes in the S&P Europe 350 and S&P United Kingdom indices, effective at the open of **Friday, June 15, 2018:**

- United Business Media Ltd. (XLON: UBM) will be removed from the S&P Europe 350 and S&P United Kingdom indices due to its acquisition by S&P Europe 350 constituent Informa PLC (XLON: INF), subject to a court hearing to sanction the deal.
- A replacement company will be added to the S&P Europe 350 index at the open of **Monday, June 18, 2018.**
